

# FROM MY PERSPECTIVE Love & Marriage & Divorce



As I struggle through the complex paperwork to finalize my second divorce, a difficult and unpleasant task at the best of times, I find myself becoming increasingly ambivalent and negative toward the notion of love and marriage. Why would anyone embark upon a legal arrangement that ends in failure almost 50% of the time? The controversial fight for gay marriage leaves me wondering the same thing. Is marriage really necessary? What is the point?

I've read the many research studies that claim married men live longer, that married people are happier and more successful in life, that marriage provides a stable environment to raise children. The latter, in particular, is an argument I accept - children need two parents.

However, given the breakdown of the institution of marriage in virtually every community and culture, it seems we are in dire need of a re-write of the rules.

A recent article suggested that respect is the key to long marriages. The secret, apparently, is not *choosing* the right mate, but *being* the right mate (Schwartz, 2005). Two people commit to each other, for better or worse, choosing to love and honour each other through tough times, willing to accept each other's shortcomings. While I agree with all of this, it seems to me that this can be done by two individuals regardless of a piece of paper to legalize the process. What is most important is being willing to stick together even when love and satisfaction are at their lowest point.

Love and satisfaction are not constants in a relationship, they "ebb and flow, depending on how people treat each other" (Schwartz, 2005). One researcher has found that satisfaction in a marriage drops when the first baby comes along, and is at its lowest when children are between 11 and 16 (no surprise to those of us who have lived through those turbulent years). The good news is, once children have left the nest, satisfaction rises, making the final stage of marriage the real honeymoon period (Smart Marriages, 2005). Again, I concur with this latter statement - I see my own parents, for example, thoroughly enjoying this late-in-life honeymoon, travelling together, and sharing a level of contentment that seems much higher than at any other point in their relationship.

The research that I find most interesting is that which indicates that staying together and avoiding separation or divorce has a positive end result - with people who get through the difficult times ultimately finding deep happiness and contentment. I have always believed that getting a divorce is far too simple, providing an easy out solution, a lack of incentive to try to weather the storm. There are exceptions, of course, abuse and repeated infidelity being the main ones. But for the most part, people who have managed to work through issues, even serious ones, to stay married, seem to be far happier and more successful in life than those who opted for divorce.

The cynical part of me does not believe in love as an essential marriage component. I've seen many marriages based on other factors - friendship, financial security, companionship. In most cases an emotional attachment develops over time that proves far more powerful than the passionate love so many base their initial marital decisions on. In the right circumstances, I believe you can grow to love your partner - and if not, you can still have a healthy relationship without love. A quasi-business relationship can flourish, providing a healthy environment for all parties, including children, without love ever entering into it. In some ways, such a relationship is even more resistant to breakup, since passion is replaced by logic and mutual need. One author pointed out that one thing people learn well in marriage is "how to hurt the other," and she suggests that marriages that last involve the ability to "hold back from saying the very thing the other most dreads hearing" during a crisis, those moments of "sheer hatred" (Klagsbrun, 1985).

With my sceptical eye, I watched the news about Charles and Camilla's marriage this past week. Many describe it a "love story" to finally see the plus-55 year old pair wed. As the much-maligned "other woman," Camilla bears the burden of blame for the break up of Charles's first marriage. As is typical in affairs of this sort, the man escapes the brunt of censure, although it is obvious that Camilla was not operating alone. But in spite of the ugliness of the affair, the divorce, and the sad aftermath of Diana's death, the relationship between Charles and Camilla has endured. Many are happy for them, enchanted by this love story that has endured such adversity. I can't help but wonder, however, what would have happened had Charles and Diana managed to work through things rather than divorce. An affair does not have to be the end - look at the success Bill and Hillary Clinton have managed to achieve. Although remaining together was no doubt difficult and challenging, they appear to now have a good relationship, one that has been highly beneficial for both of them. I don't think Hillary's presidential aspirations, or Bill's continued public respect and goodwill, would have been possible had the marriage ended in divorce. And I'm sure Chelsea is much happier with her parents together, as would William and Harry have been. In fact, it's likely that Charles's mother (Queen Elizabeth) has worked through similar rough spots and infidelity in her marriage.

Can a marriage be saved after an affair? I believe so, although I certainly would not advise anyone to put up with repeated infidelity, particularly given the risks of sexually transmitted disease. I saw a news program recently that cited extremely high rates of infidelity within a marriage, by both genders, so it's an issue that many married people will eventually confront.

A few news commentators have pointed out that after everything that has occurred, Charles really had no choice but make good on his commitment to Camilla and marry her. Perhaps it really is a love story and perhaps they really do deserve to be together after so many years and so much trouble. As much as I believe everyone has a right to happiness, however, I don't think it should be at the expense of another. This is particularly true within a relationship. Although the divorce decision may be mutual in a few situations, in most cases, one party is the "dumper" and one is the "dumpee", providing the potential for an incredible amount of pain and unhappiness. If it is truly the case that couples who make it through the difficult years achieve a true honeymoon period later in life, there should be a strong incentive to keep marriages together. Being able to "grow old together" and have companionship as you age is something I'm beginning to really appreciate the importance of. At the religious ceremony following the civil marriage, Charles and Camilla, before the eyes of both those in the chapel and a worldwide television audience, asked forgiveness for their sins and promised that they had 'resolved to be faithful' to each other in this marriage. Hopefully, they will manage to do so.

As for me, I'm far too pessimistic about the whole process to be completely objective. My solution is to resolve never to get married again and to encourage my children to be cautious - take your time before deciding to get married, and take your time before deciding to end a relationship. If, prior to getting married, everyone was required to go through the same kind of difficulty and heartache that accompanies a divorce, no doubt the institution of marriage would be considered far more valuable.





# **Recipe and Retraction**

Firstly, part of my gradual maturing process as an individual is learning how to admit when I'm wrong, so here it goes...

In a column a couple of weeks ago, I took a pretty sniffy attitude towards those people who have a keen appreciation for high quality wines. Quoting the cheeky and sardonic American writer Nick Tosches, I dismissed these people as "pseudo-connoisseurs." I then brazenly went on to more or less claim that there is little real difference between a bottle of cheap, homemade wine and the stuff that regularly gets *oooohed* and *aaaahed* over at wine tastings and fine restaurants.

Well, as a reader quite rightly pointed out, it is a bit illogical to assert that high quality ingredients make all the difference in other areas of food enjoyment, but to deny their validity in the making of wine. Obviously, creating a fine bottle of wine is an act of craftsmanship requiring vast technical experience and artistic intuition. That a ten dollar bottle of *Yellowtail* tastes every bit as good to me as *Chateau Neuf du Pape* is a just reflection of my lack of knowledge in this area. My husband's enjoyment for the most headache-inducing modern jazz I've ever heard is completely lost on me, but I'm sure he hears far more in the music than I do.

The swipe I rather clumsily took in my previous column was not meant to be directed at those people with the ability to genuinely appreciate a good bottle of *Syrah* or *Pinot Noir*, but rather at all of the self-important hoopla that is connected to the enjoyment of high calibre plonk. It's an argument equally applicable in the areas of gourmet cuisine, art, literature, fashion, and any number of other areas. To me, a good book is one that's fun to read; a good song is something you can dance to, cry to, or sing along with; and good food and drink is just whatever goes down well. I suppose you can take the girl out of rural Alberta, but you can't take rural Alberta out of the girl. So, I offer an apology in admitting that some of my best friends are wine connoisseurs.

Secondly, I have had a serious thing for olives ever since my first experience with a Greek salad many years ago in Medicine Hat, Alberta. That's why my eyes and taste buds lit up when one of my co-workers recently brought in a Mason jar filled with marinated olives for a pot-luck lunch. The following recipe renders four or five cups of the heady and delicious mixture:

2 cups brine cured Kalamata olives
2 cups brine cured green olives
1 cup of extra-virgin olive oil
The juice of two or three large lemons
One thinly-sliced fennel bulb
1/4 cup finely-chopped red onion
One can of anchovy fillets
Generous quantities of fresh tarragon, basil and thyme
1/4 cup Balsamic vinegar
Lots of freshly ground black pepper

Chop up the anchovies and mix everything together in a large bowl, then refrigerate for two or three days (or at least overnight). Serve at room temperature with Roma tomatoes, a crispy baguette, and a plate of freshly grated Parmesan drizzled with more Balsamic vinegar, and whatever wine you truly enjoy.

Oh and for an incredibly delicious French tapenade that takes about two minutes to prepare, try blending a can of black olives with a half dozen garlic cloves, three tablespoons of capers, half a cup of extra-virgin olive oil, and freshly ground pepper to taste. Not the most attractive looking dish, perhaps, but absolutely delicious whether you use it as a spread or as a topping for pasta. Yum!

# **Desert Island Masterpieces**

Bronchitis, walking pneumonia, measles, mumps, whooping cough, scurvy, ptomaine, toe jam, beri beri, yellow fever - you name it, and it's a pretty good bet that I was bedridden with it at some point during my infancy and preadolescence. So, while my classmates were out playing tag, practising to be soccer hooligans, setting fire to municipal buildings and generally figuring out new and ever more inventive ways to torment 68 pound asthmatic weaklings like myself, I was spending days or weeks at a time wrapped up in blankets in the living room, drinking weak tea with a splash of *me Da's* whiskey and eating kippers and custard.

In between fever dreams, I would read *Tin Tin* comics, and everything that Robert Louis Stevenson ever wrote. I would also spend hours listening to the "wireless," while my merchant marine father passed by the door muttering to himself and shaking his head in chagrin at the fickle fortunes

that had caused him to spawn what appeared to be the love child of Beatrix Potter and Edgar Allen Poe. My favourite radio program was the old BBC (British Broadcasting Corporation) Sunday morning chestnut *Desert Island Discs*, in which various celebrities would offer up the ten recordings they would choose to be stranded with, should they be lucky enough to know in advance which remote island with a power supply they would be conveniently shipwrecked near.

Okay, so there was something missing in the logic department. But I still found the idea fascinating back then, and it's stuck with me for all these years. To this day, when I find myself trapped on a long bus trip or in a waiting room, I engage in the time-wasting pursuit of doodling down lists of things that I would choose to be stranded with, preferably along with a crate of Lagavulin and a bail of British Columbia's finest. Not just recordings, but favourite books and movies, as well. I think what appeals to me so much about this is the selection criterion that I would have to use. Ten pieces of music, ten works of literature, and ten films amongst all of the hundreds of each that I've enjoyed over my lifetime. How could I narrow down the candidates?

Both provinces want to have more health care professionals available. Both provinces would also like to have them educated in their province rather than paying sufficiently high salaries to entice health care professionals from other regions.

The two solutions that the provinces have decided to take, however, are radically different and server to highlight the differing political philosophies of the two provincial governments.

In British Columbia, the provincial government is giving three million dollars to health care organizations and universities to create health care work placements, as well as update labs and curriculums to enable more people to graduate with a better understanding of their chosen profession (British Columbia, April 8, 2005). This comes in addition to earlier expenditures almost doubling the number of seats for medical education and creating 2,100 new seats for students to study nursing. Clearly B.C. feels that they have no problem with the root supply of prospective health care professionals. The government's approach is to address the bottlenecks in becoming a health care professional.

A different political philosophy is evident in Saskatchewan which is once again providing bursaries in exchange for agreements to work within the province. Spending five million dollars on this program in 2005, the Saskatchewan government will be directly funding 500 continuing and new bursaries (Saskatchewan, April 6, 2005). For the Saskatchewan government, it seems that they perceive the problem not as one of a lack of room for students in the system, but rather a lack of interest by students due to the costs involved in obtaining the education.

When we look at the differing political philosophies, we see that British Columbia likes to support organizations, and hopes that they will support the people. In contrast, Saskatchewan prefers to support the people directly, and hopes the organizations will have the ability to take advantage of it.

It will be interesting to see in the coming years which province had the better idea. Personally, I'm rooting for Saskatchewan.

#### Ford Focuses on Fuel Cells

In British Columbia, five Ford Focus Fuel Cell Vehicles (FCVs) will be on the streets as part of a three-year demonstration project (Canada, March 31, 2005). The difference between these cars and the standard Ford Focus is that these vehicles will be powered by hydrogen-burning fuel cells. This means that the only emissions they will generate are water vapor particles.

Four and a half million dollars were given by the federal government in support of this project, which hopes to prove that hydrogen powered personal vehicles are a viable means of transportation in Canada. This aligns with British Columbia's desire to have a *Hydrogen Highway* developed in time for the 2010 Olympic and Paralympic Games. It's also a step toward Canada being able to meet its requirements for the Kyoto Agreement. However, once again it's a step that is primarily driven by the province, and not by the federal government.

We have yet to see any federal plan emerge for meeting Kyoto's requirements. Hopefully, initiatives like these taken in British Columbia can provide some inspiration for the federal government.

At the very least they'll make it impossible to claim that nobody could have done better.

# QUEBEC STUDENTS SUCCEED IN HAVING GRANTS RESTORED Debbie Jabbour

After five weeks of a strike by 180,000 university and college students, the Quebec government has announced that cuts to the \$103 million student grant program will not occur. Instead, an amount of \$482 million will be reinvested in the grant program over the next five years, funds that will be taken from the Federal Canada Millennium Scholarship Foundation.

Quebec Education Minister Jean-Marc Fournier says he is happy for the students, and that this agreement is "proof it can work when we have a collaborative effort with Ottawa - it can work for all Quebecers" (Canadian Press, April 2, 2005).

Students have been aggressive in their protests against the student grant program cuts, and the strike finally seems to have tipped the scale in their favour. The Canadian Federation of Students Quebec (CFSQ) has suggested provincial money should be used to solve this problem, rather than federal money (Weatherall, April 4, 2005). With the money for Quebec students coming from the federal government, one has to wonder whether similar action by students across Canada would prompt the federal government to increase grants to all provinces. This action by students could perhaps result in bringing tuition in the rest of Canada closer to that of Quebec students who have long enjoyed the lowest tuition in Canada.

# Women you should know



## Pitseolak Ashoona (1904-1983)

Pitseolak Ashoona was born in Nottingham Island in the Northwest Territories. She was raised on Baffin Island and became a renowned Inuit Canadian artist. Pitseolak grew up living a traditional Inuit lifestyle that is reflected in her extensive artwork. She and her husband raised 12 children, some of whom followed her artistic path. Pitseolak's art collection is comprised of over 7,000 images, with many focusing on the day-to-day life of the Inuit people. She received many honours during her life, including becoming an elected member of the Royal Canadian Academy of the Arts in 1974. In 1975 she was awarded the Canada Council Senior Arts Grant. Her most prestigious award is the Order of Canada that she received in 1977 and is the highest award a civilian can receive. In 1977 she was also recognized by having her picture-displayed on a Canadian stamp in celebration of International Women's Day. Pitseolak Ashoona died on May 26, 1983.

## Back on Track

In June 2003 it occurred to me that our baby girl Hilary would be leaving home to attend university. By this time Roy had been trucking into the United States for about a year and a half. At that point I had already been home and "semi-retired" for nearly two years.

It dawned on me that I would soon be alone for large chunks of time. Not that that particularly scared me. I've never understood those people who can't seem to stand their own company and always need the stimulation of others. But I also knew I didn't want to turn into one of those women who watches soap operas all day and has forty cats in the house.

However I did recognize that all of my current projects/passions are solitary pursuits--painting, writing, university course work, gardening, interior design--and that human contact is a good thing. A conversation with my aunt led to a part-time (two days a week) job as an accounts payable/accounts receivable clerk at a Vegreville business.

Have you ever had things take on a life of their own? Before too long it was three days a week. Because of extensive store renovations we moved to a temporary location and back again all in the space of about four months. Two months after that we converted to a totally new point-of-sale, inventory and accounting computer system. Somewhere along the way the job became full-time and even that wasn't enough time to get everything done.

It became increasingly obvious that my plan for how my life was supposed to be going had somehow slipped out of my grasp. I don't want to come across as the victim because I very consciously agreed to all that was asked of me--that's how I'm wired. If there's a job or a challenge and I feel I can make a difference then count me in. But

when you literally can't do your own banking in person and your grip on basic household chores like cooking, vacuuming and laundry is getting away on you, it's time to reassess. At fifty, I have neither the stamina nor the desire to burn the candle at both ends.

On February 15th I worked my last shift. I had I intended to be gone by January 31st but worked another seven days to help get my replacement a little more comfortable and smooth the year end transition. The farewell potluck, gifts and cards had been done earlier. The longer I hung around the more it felt like one of Cher's farewell tours. Will she ever be gone?

As much as I knew leaving would be best for me, it was bittersweet as I made my rounds through the store giving everyone a final hug. My farewell letter with a personalized message for each employee had touched hearts. Knowing I had made an impact on many people made leaving at once both easier and harder. Getting my life back on track is the reward, from where I sit.

Our increasingly complex world cannot be understood today as a collection of self-contained localities. Anthropology has been quick to respond to the challenges posed by the new forms of hybridity and intensified exchange between localities, nations and world regions. One of the implications of the new approaches is that our perspective itself has changed the way we perceive culture, borders, power and change. The relationships between localities and supralocal or global institutions continue to change according to fluctuations in larger socioeconomic cultural and political processes. It is possible to argue that localities may open or close themselves to the world, according to changes in their larger, socioeconomic and cultural environment. In the meantime, the new movements for aboriginal rights and

other social movements are staking their claims on strong notions of place and locality, which are often conflated with identity and cultural belonging. Furthermore, the idiom of the nation is gaining new strength as it is redefined outside its prior identification with the boundaries of States.

The Canadian Anthropological Society / Societe Canadienne d'Anthropologie (CASCA), the Society for the Anthropology of North America (SANA), an the Facultad de Ciencias Antropológicas de la Universidad Autonoma de Yucatán (UADY) have joined to hold together their 2005 Conference in the city of Merida, Yucatan, in Mexico. This tri-national and tri-lingual anthropology conference will take place May 3-8, 2005 at the central campus of the Automous University of Yucatan. We invite you to explore with us the issues of locality, translocality, nationality and transnationality in what promises to be an exciting transnational gathering, bringing together anthropologists from around the world.

# INTERNATIONAL SYMPOSIUM ON CONFIDENTIALITY, PRIVACY AND DISCLOSURE IN THE 21ST CENTURY May 3, 2005 - Manchester, UK - http://www.ccsr.ac.uk/capri/symposium/

The issues of Confidentiality and Privacy took numerous twists and turns during the second half of the 20th Century, as the media globalisation, computing, the Internet, surveillance technology all emerged and then became more sophisticated, faster, and more efficient. As we have entered the 21st century the notion of the Grid has appeared with its promise of fast distributed analyses over multiple, very large sets of data. The potential for linking data of different types, and from different sources has become more feasible.

In the light of these changes the notion of confidentiality has itself been required to changed taking into account the new technology, but also using that technology through sophisticated systems of disclosure control and more recently through such ideas as intruder detection and data sentries. This symposium will bring together international experts in confidentiality and privacy research from the fields of law, data protection, statistics, social science and computer science to debate the implications of recent technological advances.

Key questions to be addressed are:

- How is new technology going to affect the way we view privacy, confidentiality and disclosure?
- How can technology be used to enable confidentiality rather than threatening it?
- How is disclosure risk assessed? How is that likely to change over time?

Papers will be given be experts in confidentiality and privacy: describing their research, discussing the relationship between research and policy, together with future gazing - outlining the possibilities, potential threats and opportunities. The day will be structured around eight speakers with plenty of discussion time.

Contributors: The keynote address will be give by Professor George Duncan from Carnegie Mellon University, USA. Other invited speakers include: Professor John Forster (University of Southampton); Professor JJ Salaza (University of Teneriffe); Dr Michael Carlson (University of Stockholm); Julian Stander (University of Plymouth); Dr. Dean Judson (US Census Bureau); Prof. Charles Raab (University of Edinburgh) and Dr. Francis Aldhouse (UK, Information Commission).
